Thank you for your generous support of the Tampa General Hospital Foundation. Your commitment has helped thousands of men, women, and children receive compassionate and life-saving care at our hospital.

This support took many different forms. Some of you contributed to our **Fund for the Future**, the hospital expansion project, or to one of our special funds. Others honored a loved one through a memorial. Still others attended one of our special events, volunteered for a committee, or provided leadership as a board member.

Your gifts have funded capital projects, equipment purchases, nursing scholarships, research, employee education, and special support programs for our patients and their families.

Last November, the Foundation celebrated the opening of the Emergency & Trauma Center, the centerpiece of our very first capital campaign, appropriately named Building on Excellence. Earlier in the year, we also launched our second capital campaign to help fund a new, state-of-the-art Neonatal Intensive Care Unit (NICU).

We named this important campaign **Tiny babies. Big priority.** As of December, we have raised more than \$5.8 million dollars under the superb leadership of Sam Ellison and Buck McInnis and Honorary Chairs Les and Pam Muma. Tampa General will build the Jennifer Leigh Muma Neonatal Intensive Care Unit in memory of Pam and Les's daughter. The new NICU is part of a major initiative by TGH and University of South Florida College of Medicine to apply research to transform newborn intensive care. Through the Muma's generosity, the TGH Foundation received its largest gift — \$3 million.

Net profits from our three signature events — the **Night at the Circus, Moments in Time Gala,** and **Golf Tournament** — generated more than \$650,000 for hospital programs, projects, and services. We are also proud to have been one of the charities selected by the **Outback Steakhouse Pro-Am Golf Tournament** to share the proceeds from the 2007 tournament.

We are truly grateful to the generous businesses that organized and sponsored fundraising events to benefit the foundation. They include: the Tampa Bay Lightning/Lightning Foundation and Melitta USA for **Glitz & Sticks**, benefiting the Pediatric Intensive Care Unit; the International Brotherhood of Electrical Workers Local 108 and TECO Energy for the annual **Golf Tournament** to benefit the Burn Center; Skanska for the **Fishing Tournament** to benefit the NICU; Fresh Market and Marco and Son Wine Importing and Distribution for the **Wine Gala** to benefit the Fund for the Future; and Hyde Park Village for the **Friday Night Jazz Concert** benefiting the Women's Center.

The Tampa General Hospital Foundation operates exclusively for the purpose of raising funds to support the research, education, and service missions of Tampa General Hospital. Each year, individuals, corporations, and foundations generously support the Foundation through a variety of fundraising events, individual and corporate contributions and grants. The funds raised support initiatives that touch every area of the hospital, ranging from nursing scholarships to our new Bayshore Pavilion. Each gift, small or large, makes a difference to the patients, families, physicians, and staff of Tampa General Hospital.

We offer many ways to give and the following programs may be of interest to you.

TINY BABIES. BIG PRIORITY. CAMPAIGN

Capital campaigns raise significant funds to address major institutional needs. Our “Tiny babies. Big priority.” Campaign will raise over \$7 million to completely redesign and expand our Neonatal Intensive Care Unit (NICU).

Imagine the excitement of preparing for the birth of your child, when for some unforeseen reason, the baby is born prematurely or seriously ill. We must provide the extra state-of-the-art medical care these tiny newborns need to ensure they get the best possible start in life.

The original NICU opened at Tampa General in the 1970s and moved to its current location in 1986. Since then many aspects of neonatal care have changed and the number of high-risk deliveries has substantially increased; as a result, our NICU operates at full capacity almost every day. Tampa General’s

plans for a new state-of-the-art NICU include increasing the unit’s size from under 19,000 square-feet to over 50,000 square-feet and increasing the number of beds from 42 to 84. As a safety net hospital, Tampa General serves not only babies born at TGH, but also babies transferred from other Florida hospitals — we do not want to turn away a sick infant for lack of space.

The standard design for a NICU in the 1980s was an open space plan with no private units. As a result, all babies received identical exposure to light and noise. New research indicates that a more private setting with a better controlled environment results in a faster healing process and decreased need for sedation due to drastically lowered noise levels and exposure to harsh lighting. The new NICU design will feature private rooms, which will be family-centered in design to allow active participation by parents in caregiving—this has been proven to speed up the bonding and recovering process and decrease the infant’s hospital stay.

After touring our current NICU, one donor doubled his family’s gift to the “Tiny babies. Big priority.” Campaign. He wanted to “make sure every baby was cared for in a world-class facility as nice as the new Bayshore Pavilion.” What better way to help our tiniest patients?

INNOVATIVE NURSING SCHOLARSHIPS

The fact that the United States is experiencing a nursing shortage is well documented. With baby boomers aging, the need for health care growing, and nursing colleges and universities trying to expand enrollment levels, many organizations are seeking solutions to this growing problem. Tampa General Hospital is no exception.

In determining the best way to address the nursing shortage at TGH, internal research revealed that TGH staff members who wanted to become nurses had difficulty balancing work, school, study time and family. Cutting back on work hours to allow time for school and study meant losing health and other employee benefits, which most staff members could not afford. Their desire to become an RN was apparent, but the practical feasibility of attending and

completing nursing school was extremely low. Our highly successful and innovative Nursing Scholarship Program is designed to give TGH employees the opportunity to attend nursing school full-time while working part-time and continuing to receive the equivalent of a full-time salary and their full employee benefits. Mentors at the hospital and universities advise the students throughout the program.

Upon completion of their degrees, the scholarship recipients must agree to work full-time at TGH as RNs for the same length of time they were in the scholarship program. Between the time that the Nursing

Scholarship Program began at TGH and the end of 2007, 17 employees have received nursing scholarships and eight of those 17 have graduated as registered nurses. The program has become highly successful with 94% of scholarship recipients graduating or successfully working towards their degrees.

This year a donor who experienced nurses “who cared for her parents like they would their own parents,” funded a full scholarship. The TGH Foundation has obtained funding from two Bay Area foundations and will continue to seek funding to provide more scholarship opportunities for prospective RN applicants.
